# ANNUAL REPORT ON FUTURE WATER RESOURCES DEVELOPMENT



## **Includes:**

1. All proposals submitted annually from non-federal interests for consideration in the Report. Proposals are included in either the main report or in the appendix.
2. Signed Chief's Reports and transmitted Section 203 studies for Congressional consideration of project authorization.

## **May also include:**

Additional reports/decision documents requested by Congress: e.g., ASA(CW) recommendation of releasing future water storage rights ( § 1046), inland waterways riverbank stabilization project recommendations ( § 2009), remote and subsistence harbor project recommendations ( § 2104).



# WHAT'S NEW IN 7001?



- Section 7001 has been amended in WRDAs 2016, 2018, 2020
- WRDA 2016 and 2018 largely focused on expanding criteria to include Environmental Infrastructure
- Section 127, WRDA 2020:
  - Allows project proposals for **municipal and agricultural water supply**
  - Allows modifications to an **EI assistance program** that has not been included in any previous annual report
  - Allows project modifications to a **continuing authorities program (CAP)** project that is funded by USACE.
    - Applies to CAP projects that are 100% Fed
    - Only in cases where a project modification is necessary because the project is projected to exceed, in the coming fiscal year, the maximum Federal cost of the project AND the proposed modification will result in the completion of construction
    - Not the result of a change in scope



# WHAT'S NEW IN 7001?



## Environmental Justice (Justice40)

FRN Notice: “State whether the proposal is expected to benefit disadvantaged communities, to include a description of the disadvantaged community(ies) and the potential benefits which may accrue as a result of the proposal. Army is working to modernize the USACE Civil Works program to incorporate environmental justice considerations into every aspect of the program in an effort to maximize benefits to disadvantaged communities to the furthest extent practicable within agency authorities.”

- Status as a disadvantaged community (or not) will NOT impact whether the proposal is in the main report or appendix. **Our evaluation of proposals will continue to focus on the five criteria established in Section 7001.**
- Consistent with the Administration’s direction, USACE uses the [Climate and Economic Justice Screening Tool](#) developed by the Council on Environmental Quality to identify communities that are disadvantaged for the purposes of the Justice40 Initiative.

MEMORANDUM FOR COMMANDING GENERAL, U.S. ARMY CORPS OF ENGINEERS

SUBJECT: Implementation of Environmental Justice and the Justice40 Initiative

1. **Purpose.** This memorandum provides interim guidance and direction to the U.S. Army Corps of Engineers (USACE) Civil Works programs related to the implementation of environmental justice and the Justice40 Initiative. This memorandum applies to all Civil Works programs and missions, other than the Regulatory Program. Separate guidance will be forthcoming to address environmental justice in the Regulatory Program.

# WHAT'S NEW IN 7001?



## Section 155 of WRDA 2020

Section 155 of the Water Resources Development Act (WRDA) of 2020 authorizes the Secretary to establish a program for the study and construction of new, or enlargement of existing, small water storage projects for the purpose of flood risk management, ecological benefits, water management, water conservation, or water supply.

- Authorizes \$130M annual appropriation through 2030
- \$65M per project federal cap
- Projects subject to cost-sharing requirements in Section 103 of WRDA 1986
- Specific eligibility requirements

# CRITERIA FOR INCLUSION OF A NEW OR MODIFIED STUDY OR PROJECT



1. Related to USACE authorities and one or more of the agency missions

- USACE primary missions are navigation, flood risk management, aquatic ecosystem restoration, and water supply. Recreation and/or hydropower will be considered “related” when it is performed in conjunction with one or more of the primary mission(s).





# CRITERIA FOR INCLUSION OF A NEW OR MODIFIED STUDY OR PROJECT



2. Require specific congressional authorization
3. Has not been previously congressionally authorized
4. Has not been included in a previous annual report (under 7001), **AND**
5. Able to be carried out by the USACE, if authorized

NOTE: The decision document process must be followed and completed before a project or project modification can be recommended for construction.



# WHAT ABOUT ENVIRONMENTAL INFRASTRUCTURE PROPOSALS?



- To be included in the table within the Annual Report the proposal must be for either:
  - A modification to an environmental infrastructure project authority pursuant to Section 219 of WRDA 1992, as amended **or**
  - A modification to a programmatic authority for an environmental infrastructure assistance program.
  
- Proposals for modifications to environmental infrastructure program authorities must also include a description of assistance provided to date and the total Federal cost of assistance provided to date.



# NOT ELIGIBLE FOR THE REPORT



- Proposals for studies or projects that already have authorization.
- Proposals for modifications to non-Federal activities where USACE has provided previous technical assistance (not an authorized project).
- Proposals for construction of a new project unrelated to a currently authorized Corps project that is not the subject of a complete or ongoing feasibility study.
- Proposals that are not requesting a potential future water resources development study or project (e.g., changes to legislation).



# THE FINE PRINT



The Report does not:

- Provide authorization or appropriation for a study or project
- Replace the new start selection process for studies or projects
- Prioritize studies or projects

Proposals that do not meet the criteria or do not contain all the required information will not be included in the Annual Report, but will be included in an **appendix**, citing which criteria were not met.



# PROCESSING PROPOSALS



Deadline for receipt of non-Federal Proposals is 29 August 2022.

- USACE and ASA(CW) will collectively process and evaluate proposals
- SharePoint will be used to organize the proposal information
  - Districts are the lead in evaluating and documenting the 5 criteria
  - Office of Counsel has the lead in documenting authorities
  - Districts, Divisions, RITs, HQUSACE, and OASA(CW) staff are involved in evaluating proposals prior to providing final draft report and appendix to the ASA(CW)

  - Can it be addressed via another route: CAP, FPMS, other agencies, etc.?

## Report to Congress on Future Water Resources Development

**Section 7001 of WRRDA 2014**, as amended, requires that the Secretary of the Army annually **submit to the Congress a report** that identifies, for potential congressional authorization, completed feasibility reports, proposed feasibility studies submitted by non-Federal interests, proposed modifications to authorized water resources development projects or feasibility studies, and proposed modifications to environmental infrastructure program authorities that meet all the following criteria:

- Are related to the missions and authorities of the Corps of Engineers (Corps); involve a proposed or existing Corps' water resources project or effort whose primary purpose is flood and storm damage reduction, commercial navigation, or aquatic ecosystem restoration, municipal or agricultural water supply. Proposals for recreation or hydropower are eligible for inclusion if undertaken in conjunction with a flood or coastal storm damage reduction, commercial navigation, aquatic ecosystem restoration, or municipal or agricultural water supply project or effort.
- Require specific congressional authorization.
- Have not been congressionally authorized.
- Have not been included in the main table of a [previous annual report](#).
- If authorized could be carried out by the Corps of Engineers.

The annual Report to Congress on Future Water Resources Development is to be based, in part, upon annual requests for proposals for authorization from non-Federal interests.

Section 7001 requires that the Secretary certify that the proposals included in the annual report meet the five criteria established by Congress, listed above. Any proposals that do not meet the criteria will be included in the report's appendix. Inclusion in the annual Report to Congress does not provide authorization or appropriation for a study or project.

## Report to Congress on Future Water Resources Development

**Section 7001 of WRRDA 2014**, as amended, requires that the Secretary of the Army annually **submit to the Congress a report** that identifies, for potential congressional authorization, completed feasibility reports, proposed feasibility studies submitted by non-Federal interests, proposed modifications to authorized water resources development projects or feasibility studies, and proposed modifications to environmental infrastructure program authorities that meet all the following criteria:

- Are related to the missions and authorities of the Corps of Engineers (Corps); involve a proposed or existing Corps' water resources project or effort whose primary purpose is flood and storm damage reduction, commercial navigation, or aquatic ecosystem restoration, municipal or agricultural water supply. Proposals for recreation or hydropower are eligible for inclusion if undertaken in conjunction with a flood or coastal storm damage reduction, commercial navigation, aquatic ecosystem restoration, or municipal or agricultural water supply project or effort.
- Require specific congressional authorization.
- Have not been congressionally authorized.
- Have not been included in the main table of a [previous annual report](#).
- If authorized could be carried out by the Corps of Engineers.

The annual Report to Congress on Future Water Resources Development is to be based, in part, upon annual requests for proposals for authorization from non-Federal interests.

Section 7001 requires that the Secretary certify that the proposals included in the annual report meet the five criteria established by Congress, listed above. Any proposals that do not meet the criteria will be included in the report's appendix. Inclusion in the annual Report to Congress does not provide authorization or appropriation for a study or project.

# INSTRUCTIONS ON PREPARING AND SUBMITTING PROPOSALS



## Preparing and Submitting a Proposal

The proposal period for the 2022 Report to Congress opens on April 30, 2021 for 120 days. **The deadline for proposals is August 30, 2021.** Submit your proposals online at: <http://www.wrrda7001proposals.us/>

All non-federal interests are invited to submit proposals for new Corps water resources development project study authority; modifications to an existing Corps water resources development project study authority; modifications to an existing Corps water resources development project authority; and modifications to an existing Corps environmental infrastructure program authority. Please submit one form for each study or modification to a study, project, or environmental infrastructure program authority being proposed. Do not include Confidential Business Information, information whose disclosure is restricted by statute, or any other information that you would not want to appear in the Annual Report to Congress.

We recommend completing the proposal form in one sitting and having all letters of support and other materials assembled before completing the form. The following information will be requested:

1. Contact information for the individual/agency submitting the proposal.
2. Study project / location; you'll have the option to upload a map of the study / project area (8.5"x11" PDF).
3. The name of the non-Federal interest planning to act as the sponsor, or all non-Federal interests in the case of a modification to an environmental infrastructure program authority, including any non-Federal interest that has contributed to or is expected to contribute toward the non-Federal share of the proposed feasibility study or modification.
4. A letter or statement of support from each associated non-Federal interest. Letters may be addressed generically to the U.S. Army Corps of Engineers, the local Corps District office, or the Assistant Secretary of the Army of Civil Works office. Please limit your files to a maximum of 30MB (30,000 KB) in size. Files larger than 30 MB will not be considered.
5. State if this proposal is for a feasibility study, a modification to a USACE water resources development feasibility study authority, a modification to a USACE water resources project authority, or a modification to a USACE environmental infrastructure program authority.
6. If the proposal is for a modification, the name of the authorized study, project, or environmental infrastructure program must be specified.
7. If the proposal is for a modification to an environmental infrastructure program authority, a brief description of the assistance provided to date and total Federal cost of assistance provided to date must be provided.



## Report to Congress on Future Water Resources Development

Section 7001 of WRRDA 2014, as amended, requires that the Secretary of the Army annually **submit to the Congress a report** that identifies, for potential congressional authorization, completed feasibility reports, proposed feasibility studies submitted by non-Federal interests, proposed modifications to authorized water resources development projects or feasibility studies, and proposed modifications to environmental infrastructure program authorities that meet all the following criteria:

- Are related to the missions and authorities of the Corps of Engineers (Corps); involve a proposed or existing Corps' water resources project or effort whose primary purpose is flood and storm damage reduction, commercial navigation, or aquatic ecosystem restoration, municipal or agricultural water supply. Proposals for recreation or hydropower are eligible for inclusion if undertaken in conjunction with a flood or coastal storm damage reduction, commercial navigation, aquatic ecosystem restoration, or municipal or agricultural water supply project or effort.
- Require specific congressional authorization.
- Have not been congressionally authorized.
- Have not been included in the main table of a [previous annual report](#).
- If authorized could be carried out by the Corps of Engineers.

The annual Report to Congress on Future Water Resources Development is to be based, in part, upon annual requests for proposals for authorization from non-Federal interests.

Section 7001 requires that the Secretary certify that the proposals included in the annual report meet the five criteria established by Congress, listed above. Any proposals that do not meet the criteria will be included in the report's appendix. Inclusion in the annual Report to Congress does not provide authorization or appropriation for a study or project.
