STARTING A NEW FEASIBILITY STUDY?



- PDTs are challenged with activities outlined in Planning Bulletin 2018-01s for the first 3-4 months after FCSA.
- Recent requirements for vertical alignment and a decision on 3x3 waivers in the VTAM occurs much earlier in the process than before (90-120 days).
- Greater emphasis on benefit evaluation across the four accounts, environmental justice, climate change, floodplain use and nonstructural plans...to name a few!

FUN FACT – PDTS ARE IN A RACE AGAINST TIME!



Time Considerations	
90 days	12.85 weeks = 90 days
~90 days	13 weeks = 91 days
During 90 days	~24 weekend days (Mon start /Fri end)

During 90 days there are ~66 working days

1-2 Federal Holidays typically occur in each quarter. More in the last few months of a year. This further reduces the number of working days.

Over the Course of 3 Years

Weekend Days	312 days
Federal Holidays	33 days

345 days are non-work days






PLANNING MENTOR PROGRAM AS ENVISIONED



- The stated objective of the program was to further drive the enterprise cultural shift to risk management, and to assist PDTs implementing the methodologies of riskinformed planning as detailed in the Planning Manual Part II: Risk-Informed Planning.
- Concept was developed in conjunction with Risk Champions who were in essence the MSC Planning Chiefs.
- Originally solicited volunteers who sent an application. MSC planning Chiefs selected from their regions and pool was limited by funding for a meeting held in Feb 2018 to train in Risk-Informed Planning.






WHAT SUPPORT CAN A PLANNING MENTOR PROVIDE?



- Help with creation of six pieces of paper
- Active participation in planning for and executing scoping/charrettes (in-person attendance)
- Assist with first planning iteration (available data)
- Develop/review risk register entries with PDT
- Provide feedback/support for milestone preparation and read ahead materials
- Assist with plan formulation strategies, screening criteria, and the four accounts evaluation
- Assistance with mission or project purpose-related policies and evaluations, depending on areas of expertise






PLANNING MENTORS – WHO ARE THEY?



- Mentors can help newly formed PDTs navigate the risk informed planning process successfully, especially during the first 120 days of the feasibility study!
- Concept started in 2018 when a selected group of planners were trained as mentors in the application of risk-informed planning.
- Since 2017, Water Resources Certified Planners (WRCPs) have been identified as our most capable senior planners with skillsets that make them ideal mentors. We now have over 100 WRCPs!

TWO RECENT FRM SCALES OF MENTORING



- Lumber NC needed a planning mentor because the district planner was new and inexperienced and there was more intense level of effort required to assist the team. The mentor was involved on a day-to-day basis and in production.
- Waccamaw needed a mentor for a junior planner. However, the junior planner only needs general oversight and review of products, so it is more an advisor/mentor role.

TAKEAWAY... the level of effort on behalf of the mentor is really scale-able to what the team needs

Enable & Operationalize Risk Informed Decision Making through SMART Planning

Planning Mentor – Judy McCrea Charter for San Francisquito Creek study Date: 3/16/18

A. CONTEXT:

The Planning Mentor program has been established as a resource to ensure PDT success in delivering of a project to solve a water resources related problem.

A trend analysis of the current Planning portfolio identifies that teams are struggling to meet early milestone time and cost commitments. The goal is for studies to reach the Alternatives Milestone within the first 2-3 months from signing of FCSA and the Tentatively Selected Plan Milestone within a year of signing the FCSA. Planning Mentors will assist teams apply risk-informed decision making and aligning the level of detail with the areas of uncertainty that must be reduced to make the decision at hand Planning Mentors will train PDTs and support their ability to improve project delivery.

B. MISSION/OBJECTIVE

The mission of the Planning Mentor program is to provide a short-term boost to help coach, mentor and train Lead Planners and PDTs on risk informed decision making, emphasizing the 'R' in SMART, and utilizing the techniques and principles in the Planning Manual Part II: Risk Informed Planning (IWR Report 2017-R-03).

The overall objectives of a Planning Mentor are to:

- Coach and mentor lead planners on all SMART Planning principles and procedures.
- Coach and mentor PDTs through early iterations of risk-informed planning process and rapid risk analysis, applying the methodologies in the Planning Manual Part II: Risk Informed Planning.
- Coach lead planners & PDTs on risk management (assessment, communication, and mitigation).
- Build capacity and risk management competence by assisting PDTs to emphasize the 'R' in SMART Planning, empowering them to make risk-informed decisions.
- Mentor PDTs on how to tell the risk story.
- Share lessons learned to ensure the Planning and allied Communities of Practice continually improve.
- Support new start studies and high profile projects.

- Less formal arrangements might work for your PDT and situation. However, requests should include expectations for assistance!
 - The concept is to provide roughly 40 hours of labor so however it makes the most sense to use it is up to the PDT, the Planning Chief and the Planning Mentor.
- Don't forget to include the PCX so they can stay involved with your study and mentor throughout the process!



SO WHY CONSIDER GETTING A MENTOR?



- If it has been a while since your district has completed a specifically authorized feasibility study...you might benefit from a mentor!
- If overall, your district planning staff is less experienced...you might try adding a mentor!
- If you have a new, weird, or different problem under your study authority...you could ask for a mentor!

A mentor can help you engage with the broader PCoP!



HOW DO I GET A MENTOR ASSIGNED?



- District Planning Chiefs make a request by sending an email to Karen Miller <u>karen.v.miller@usace.army.mil</u> and cc the MSC Planning and Policy Chief.
- PCoP "seed money" is available on a first-come, first-serve basis (\$5-10k per study) for mentor assignments.
- This initial PCoP funding will be made available for labor (if mentor is district funded) and travel can also be requested.
